3. Have TCC and TNC met the standard for recovery of affiliate costs under PURA, Tex. Util. Code § 36.058, and have costs been appropriately assigned between TCC, TNC and their affiliates?
4. Are TCC's and TNC's proposed transmission and distribution rates just and reasonable, and do the proposed rates comply with all relevant laws and Commission requirements?
5. Should the Commission approve TCC's request for riders to collect energy efficiency costs, municipal franchise fees and property tax costs?


