MOTION TO INTERVENE OF NUCOR STEEL - TEXAS

Nucor Steel - Texas ("Nucor"), a division of Nucor Corporation, pursuant sections 22.102, 22.103(b) and 22.104 of the Procedural Rules of the Public Utility Commission of Texas ("Commission"), hereby moves to intervene in the abovecaptioned proceeding. Nucor states the following as grounds for its Motion:

Nucor requests that the Commission and all parties to this proceeding serve copies of all notices, correspondence, pleadings, briefs, requests for information, and other documents upon Nucor's representatives at the Austin address shown above.

3. On April 3, 2007, the present docket was initiated upon receipt of correspondence from Kohlberg, Kravis, Roberts & Co. and Texas Pacific Group providing the Commission with "the legally binding stipulation and agreement of Texas Energy Future Holdings Limited Partnership ('TEF')" that TEF would take a series of actions with respect to TXU Electric Delivery Company upon consummation of the proposed merger transaction discussed in the correspondence. On April 25, 2007, Oncor Electric Delivery Company ("Oncor") (formerly TXU Electric Delivery Company) and TEF filed a *Joint Report and Application* pursuant to PURA Section 14.101 and P.U.C. Subst. R. 25.75. The Application requests, *inter alia*, that the Commission make a timely determination that the transaction described in the *Joint Report and Application* is consistent with the standards set out in PURA Section 14.101. Those standards include a determination that the transaction is consistent with the public interest.

4. Nucor has standing to intervene in this proceeding under Section 22.103(b)(2) of the Commission's Procedural Rules. Nucor owns and operates a steelmaking facility in Jewett, Texas, and is a large transmission/distribution customer of Oncor. As one of Oncor's largest customers, Nucor has a justiciable interest that may be adversely affected by the outcome of this proceeding.

WHEREFORE, for the reasons set forth above, Nucor Steel-Texas respectfully requests that its Motion to Intervene be granted and that Nucor be allowed to fully

participate in all aspects of this proceeding. Nucor further requests any other and further relief to which it may be justly entitled.
