Please provide the workpapers showing the derivation of MFF revenues in column g of Attachment B.

Response:

See the attached schedule. Footnote 1 to Column g of Attachment B to the Company's Application in this docket notes that the figures in Column g did not include data regarding Schedules EAPS and SMS. Schedules EAPS and SMS information is identified and provided in the attached schedule. Also, as indicated in the attached schedule, the estimated average per kWh charge for the MFF Rider is \$0.00271, rather than the \$0.0020 amount referenced in footnote 2 to Column g of Attachment B. Finally, the attached schedule notes that the ratio of "Inside City Limits to Total" used in the schedule is based on the twelve-months ended June 30, 2007. This period was used because, when Attachment B was prepared, the analyst did not have ready access to the corresponding data for the test year ended March 31, 2007.
