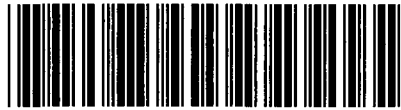



AMENDMENT NO. 3 TO ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT

This Amendment No. 3 (this "Amendment") to the ERCOT Standard Generation Interconnection Agreement dated July 16, 2019 (as previously amended on January 24, 2020 and on March 06, 2020, collectively the "Agreement") is made and entered into the 1 day of ~~June~~ ^{July} 2020, between Rayburn Country Electric Cooperative, Inc ("Transmission Service Provider"), and BT Kellam Solar, LLC, ("Generator"), each sometimes hereinafter referred to individually as a "Party" or both referred to collectively as the "Parties".

In consideration of the mutual promises and undertakings herein set forth and other good and valuable consideration, the parties hereby agree to amend the Agreement as follows:
