**AMENDMENT ONE TO
ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT**

This Amendment One ("Amendment") to the Red-Tailed Hawk Solar Project Electric Reliability Council of Texas Standard Generation Interconnection Agreement, (the "SGIA") dated ~~June 22, 2020~~, is made between AP Solar 6, LLC ("Generator") and **CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC** ("CenterPoint Energy"), (collectively, "the Parties") effective on the 4th day of August, 2021. In consideration of the mutual promises and undertakings herein set forth, Generator and CenterPoint Energy agree to amend the SGIA as follows:

Exhibit "B" dated August 28, 2020 is replaced with the Exhibit "B" dated August 4, 2021, which is attached to this Amendment One.

Except as otherwise expressly provided for herein, the SGIA will continue in full force and effect in accordance with its terms.

Generator and CenterPoint Energy have caused this Amendment to be executed in several counterparts, each of which shall be deemed to be an original, but all shall constitute one and the same instrument.

1. Interconnection Option chosen by Generator (check one):

B. The CIAC, if any, described in Exhibit "C"; and

C. The Security described in Exhibit "E."

3. The TIF In-Service Date is the later of **October 5, 2022** or 18 months after TSP's receipt of the Prerequisite Items.

4. The scheduled Commercial Operation Date is the later of **March 31, 2023** or 3 months after the In-Service Date.

The Parties may change the dates and times in this Exhibit B in accordance with Section 4.5 of Exhibit "A."
