# EXHIBIT 1

**AMENDMENT ONE TO  
ERCOT STANDARD GENERATION INTERCONNECTION  
AGREEMENT**

This Amendment One (“Amendment”) to the Electric Reliability Council of Texas Standard Generation Interconnection Agreement, (the “SGIA”) dated April 7, 2022, is made between **Callisto I Energy Center LLC** (“Generator”) and **CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC** (“CenterPoint Energy”), (collectively, “the Parties”) effective on the 8<sup>th</sup> day of August 2022.

In consideration of the mutual promises and undertakings herein set forth, Generator and CenterPoint Energy agree to amend the SGIA as follows:

Exhibit “B” dated April 7, 2022, is deleted in its entirety and replaced with the Exhibit “B” dated August 8, 2022, which is attached to this Amendment One.

Except as otherwise expressly provided for herein, the SGIA will continue in full force and effect in accordance with its terms. This Amendment and the SGIA constitute the entire agreement with respect to the matters set forth herein. In the event of any conflict between this Amendment and the SGIA, this Amendment shall control. This Amendment is governed by, and shall be construed in accordance with the laws of the State of Texas.

Generator and CenterPoint Energy have caused this Amendment to be executed in several counterparts, each of which shall be deemed to be an original, but all shall constitute one and the same instrument.

**Exhibit “B”  
Time Schedule**

1. Interconnection Option chosen by Generator (check one):  
 Section 4.1.A. or  Section 4.1.B

If Section 4.1.B is chosen by Generator, the In-Service Date(s) was determined by (check one):  
(1) N/A good faith negotiations, or (2) N/A designated by Generator upon failure to agree.

2. Generator must deliver each of the following items (collectively, the “Prerequisite Items”) to TSP by no later than April 11, 2022 (the “Scheduled Start Date”):

- A. The Notice to Proceed defined in Section 4.3.D of Exhibit “A”;
- B. The CIAC, if any, described in Exhibit “C”; and
- C. The Security described in Exhibit “E.”

Generator acknowledges that if the Prerequisite Items are not fulfilled by the Scheduled Start Date above, then the Scheduled Start Date shall be extended on a day-for-day basis until the Generator fulfills the Prerequisite Items.

3. The TIF In-Service Date is the later of August 17, 2023, or 15 months after TSP’s receipt of the Prerequisite Items.

Generator acknowledges that ERCOT may impose transmission line outage restrictions on TSP (the “Outage Restriction”) during the months of May through September of any given calendar year due to summer load peaks (the “Outage Restriction Period”). If TSP’s ability to meet the TIF In-Service Date is impacted due to an Outage Restriction, the TIF In-Service Date may be deferred to a date no earlier than October 1<sup>st</sup> of the same calendar year after the Outage Restriction Period.

4. The scheduled Commercial Operation Date is the later of November 17, 2023, or 3 months after the TIF In-Service Date.

5. The TIF In-Service Date and scheduled Commercial Operation Date shall each be extended day-for-day for each calendar day the following milestones are not achieved:

- A. TSP must take ownership or possession of the deed(s) and/or easement(s) for the TIF property by August 17, 2022.
- B. If applicable, Generator shall provide an all-weather, permanent access road and available for use by the TSP for the construction and future maintenance of the TIF by September 1, 2022.

The Parties may change the dates and times in this Exhibit B in accordance with Section 4.5 of Exhibit “A.”
