AMENDMENT THREE TO ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT

This Amendment Three ("Amendment Three") to the SBranch Solar Project Electric Reliability Council of Texas Standard Generation Interconnection Agreement, (the "SGIA"), dated July 25, 2020, is made between **CG** Wharton County, LLC ("Generator") and CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC ("CenterPoint Energy"), (collectively, "the Parties"), effective on the <u>10</u> day of March, 2023. Capitalized terms used but not otherwise defined in this Third Amendment shall have the respective meanings assigned to such terms in the SGIA. In consideration of the mutual promises and undertakings herein set forth, Generator and CenterPoint Energy agree to amend the SGIA as follows:

Exhibit "B" dated July 25, 2020 is replaced with the Exhibit "B" dated March $\underline{10}$, 2023, which is attached to this Amendment Three.

Except as otherwise expressly provided for herein, the SGIA will continue in full force and effect in accordance with its terms.

Generator and CenterPoint Energy have caused this Amendment to be executed in several counterparts, each of which shall be deemed to be an original, but all shall constitute one and the same instrument.

The scheduled Commercial Operation Date is the later of January 31, 2024 or 3 months after the In-Service Date.

The Parties may change the dates and times in this Exhibit B in accordance with Section 4.5 of Exhibit "A."
