AMENDMENT NO. 2 TO ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT FIVE WELLS STORAGE LLC (FIVE WELLS STORAGE) – GINR 23INR0159

This Amendment No. 2 ("Amendment") to the ERCOT Standard Generation Agreement by and between Oncor Electric Delivery Company LLC ("Transmission Service Provider" or "TSP") and Five Wells Storage LLC (formerly Five Wells Solar Center LLC) ("Generator"), dated February 27, 2023 ("Agreement") is made and entered into this <u>22</u> day of <u>March</u>, 2024 between Transmission Service Provider and Generator, each hereinafter sometimes referred to individually as "Party" or both referred to collectively as the "Parties."

In consideration of the mutual promises and undertaking herein set forth and other good and valuable consideration, the Parties hereby agree to amend the Agreement as follows:

- 1. This Amendment shall be effective upon execution by both Parties.
- 2. All references to Five Wells Solar Center LLC in this Agreement are hereby deleted and replaced with Five Wells Storage LLC. Five Wells Storage LLC is the successor-by-assignment to Five Wells Solar Center LLC.
- 3. Exhibit "D" to the Agreement is hereby deleted and replaced with the Exhibit "D' attached to this Amendment.
- 4. Except as otherwise expressly provided for herein, the Agreement shall continue in full force and effect in accordance with its terms.
