ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT  
GIR 21INR0303 – Ben Milam Solar 2 LLC (MANDORLA SOLAR)**


This Amendment No. 2 (“Amendment”) to the ERCOT Standard Generation Interconnection Agreement, dated September 19, 2022, by and between Oncor Electric Delivery Company LLC (“TSP”), a Delaware limited liability company, and Ben Milam Solar 2 LLC (“Generator”), as amended by that certain Amendment 1 to ERCOT Standard Generation Interconnection Agreement, dated as of March 10, 2023 (as may be further amended, amended and restated, supplemented or otherwise modified from time to time, the “Agreement”) is made and entered into as of the latest date executed below but is effective as of September 19, 2022, by and between TSP and Generator, collectively referred to hereinafter as the Parties. In consideration of the mutual promises and undertakings herein set forth, the Parties hereby agree to amend the Agreement as follows:

1. The following dates set forth on Exhibit “B” to the Agreement are deleted and replaced with the following:
  - In Service Date: **March 28, 2024**
  - Scheduled Trial Operation Date: **May 1, 2024**
  - Commercial Operation Date: **June 29, 2024**
  - Date by which Generator will have in place the communication facilities specified in Exhibit “C”: **March 27, 2024**
  - Date by which Generator will have the 4-hole pads connected to Generator’s bus at the Point of Interconnection for TSP’s jumper terminations: **March 13, 2024**
2. Item 12 (k.) under Supplemental Terms and Conditions of Exhibit “C” attached to the Agreement is deleted in their entirety, and the Item 12 (k.) of Exhibit “C” attached to this Amendment is hereby added to the Agreement in lieu thereof. The Parties agree that any noncompliance with the requirements of Item 12 (k.) of Exhibit “C” arising before the date hereof is hereby waived.
3. Exhibit “D” to the Agreement is deleted in its entirety and replaced with the **Exhibit “D”** attached here to and made a part hereof.
4. Except as otherwise expressly provided for herein, the Agreement shall continue in full force and effect in accordance with its terms.

IN WITNESS WHEREOF, the Parties have caused this Amendment to be executed in several counterparts, each of which shall be deemed an original but all shall constitute one and the same instrument.

**Interconnection Details**

12. Supplemental Terms and Conditions:

- k. Reactive Power (Plant not generating real power) – Generator will install, operate, and maintain Plant and/or GIF facilities and implement an automatic operating scheme, as necessary, to establish and maintain reactive power within a range of +/- 5 Mvar, as measured at the Point of Interconnection, at all times when the Plant is not generating real power into the ERCOT grid and the Plant and/or GIF is acting as a load. Such facilities and automatic operating scheme will be installed and functional by the Trial Operation Date specified in Exhibit "B". Generator will provide, for review and comments, written documentation to TSP specifying the design details of all equipment (including size, number, and location of any capacitors and/or reactors and controls) and automatic operating scheme which it will install to meet these requirements by the date specified in Exhibit "B". Notwithstanding TSP's obligations in the remainder of this Agreement, TSP shall have no obligation to establish an electrical interconnection with the Plant until Generator completes the installation of the reactive power facilities and automatic operating scheme specified in this paragraph.
