Re: American Electric Power, Docket No. ER19-873-____ Withdrawal of Amendment of Service Agreement No. 97 under the Open Access Transmission Service Tariff of the American Electric Power System

Dear Secretary Bose:

Pursuant to Section 35.17(a) of the Federal Energy Regulatory Commission's ("Commission") rules,¹ American Electric Power Service Corporation ("AEPSC"), on behalf of its affiliate AEP Texas Inc. ("AEP"), moves to withdraw its amendment filing submitted in the above-referenced docket on January 28, 2019 ("January Filing").

Through the January Filing, AEPSC sought to amend an effective Interconnection Agreement among AEP, Lighthouse Electric Cooperative, Inc. ("LHEC") and Golden Spread Electric Cooperative, Inc. ("GSEC") ("Amended Agreement") filed January 28, 2019. As AEPSC explained in the January Filing, the need to amend arises to substantially conform to the terms and conditions of other interconnection agreements that were accepted by the Commission.

AEPSC is withdrawing the January Filing in order to better coordinate with the filing of a complementary Southwest Power Pool, Inc. ("SPP") LHEC Interconnection & Local Delivery Service Agreement ("ILDSA") filing that will address the Points of Interconnection that are being proposed to be terminated in the Amended Agreement. AEPSC will resubmit a new filing with the amended tariff record associated with the Amended Agreement contemporaneously with the filing of the ILDSA by SPP.

AEPSC requests an effective date of March 22, 2019 for this withdrawal. AEPSC further requests waiver of any of the Commission's notice requirements as necessary to allow such effective date. To the extent that AEPSC has not complied with the technical requirements of the Commission's regulations applicable to this filing, AEPSC respectfully requests waiver of such regulations.
