# ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT GIR 23INR0021 – HORNET SOLAR, LLC (OZARK TRAIL)

This Amendment No. 4 ("Amendment") to the ERCOT Standard Generation Interconnection Agreement, dated December 6, 2021, between Oncor Electric Delivery Company LLC ("TSP"), a Delaware limited liability company, and Hornet Solar LLC ("Generator"), a Delaware limited liability company, ("Agreement") is made and entered into this <u>15</u> day <u>August</u>, 2024 between TSP and Generator, collectively referred to hereinafter as the Parties. In consideration of the mutual promises and undertakings herein set forth, the Parties hereby agree to amend the Agreement as follows:

- 1. The Exhibit "B" to the Agreement is deleted in its entirety and replaced with the Exhibit "B" attached hereto and made a part hereof.
- 2. Exhibit "D" attached to the Agreement is deleted in its entirety and the Exhibit "D" attached to this Amendment is hereby added to the Agreement in lieu thereof.
- 3. Except as otherwise expressly provided for herein, the Agreement shall continue in full force and effect in accordance with its terms.

IN WITNESS WHEREOF, the Parties have caused this Amendment to be executed in several counterparts, each of which shall be deemed an original but all shall constitute one and the same instrument.
