Dear Commissioners:

Please accept this third supplementary complaint against Oncor Electric Delivery Company LLC. ("Onco") in the above-referenced transaction.

I ask that the Public Utility Commission take note of the ongoing road damages suffered in Franklin County in far northeastern Texas. Damages through Oncor operations; a company which does not provide electricity in Franklin County. Oncor is working to further its profit through electric transmission of electricity generated by foreign renewable energy developers; transmitting electricity to the Dallas market with Oncor to pass expenses on to ratepayers and Texas taxpayers.

We forward a copy of the Commissioners Court Agent for Franklin County, Texas, for December 9, 2024. Please see agenda item 5 setting forth a damage claim of \$113,855.00 for damages to county roads. The claim was not paid by Oncor and there was no settlement. Oncor has ongoing construction in this county whether Oncor is doing the work, is subcontracting the work or is requiring the work under terms of connection agreements with foreign developers. Please deny any new transmission line plans for construction in Franklin County, Texas. We cannot allow the destruction of our land nor the cost for construction to accommodate unreliable intermittent wind and solar projects hundreds of miles from cities. We cannot allow the heavy footprint of wind and solar energy in Texas, destroying agricultural and timber land, impacting nature and man.
