**AMENDMENT NO. 4 TO
ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT
CHILLINGHAM STORAGE – GINR 23INR0079**

This Amendment No. 4 (“Amendment”) to the ERCOT Standard Generation Interconnection Agreement by and between Oncor Electric Delivery Company LLC (“Transmission Service Provider” or “TSP”) and Chillingham Solar LLC (formerly 250LB 8ME LLC) (“Generator”), dated February 4, 2022 (“Agreement”) and as amended on May 27, 2023 is made and entered into this 31 day of october, 2024 between Transmission Service Provider and Generator, each hereinafter sometimes referred to individually as a “Party” or both referred to collectively as the “Parties.”

In consideration of the mutual promises and undertaking herein set forth and other good and valuable consideration, the Parties hereby agree to amend the Agreement as follows:

1. This Amendment shall be effective upon execution by both Parties.
2. All references to Chillingham Solar LLC for 23INR0079 (Chillingham Storage) are hereby changed to Chillingham Storage LLC.
3. Sections 4 and 5 of Exhibit “C” to the Agreement are hereby deleted and replaced with the following Sections 4 and 5 for Chillingham Storage (23INR0079).

4. Number and size of Generating Units:

Forty-five (45) storage inverters each rated at 4.0 MVA with a total gross capacity of 180 MVA. The plant will be dispatched at 155.171 MW, measured at the generator terminals, and 153.93 MW, measured at the 34.5 kV bus.

The Parties will amend this Exhibit “C” as necessary to reflect any changes Generator makes to the number and size of generating units.

5. Type of Generating Unit:

Sungrow SC4000UD-MV-US storage inverters

The Parties will amend this Exhibit “C” as necessary to reflect any changes Generator makes to the manufacturer, model, or type of generating units.

4. Except as otherwise expressly provided for herein, the Agreement shall continue in full force and effect in accordance with its terms.
