

## AMENDMENT NO. 2

## ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT

GIR 24INR0274- Boxcar Energy Storage, LLC (Bufflehead Bess)

This Amendment No. 2 ("Amendment") to the ERCOT Standard Generation Interconnection Agreement, dated April 10, 2024, between Oncor Electric Delivery Company LLC, a Delaware limited liability company ("Transmission Service Provider" or "TSP") and **Boxcar Energy Storage, LLC** ("Generator") ("Agreement") is made and entered into this <u>5<sup>th</sup></u> day of <u>March</u>, 2025 between TSP and Generator, collectively referred to hereinafter as the Parties. In consideration of the mutual promises and undertakings herein set forth, the Parties hereby agree to amend the Agreement as follows:

- **1.** Paragraph 1 of Exhibit "C" to the Agreement are hereby deleted in their entirety and replaced with Exhibit "C" paragraph 1 as follows:
  - Name: Boxcar Energy Storage LLC Bufflehead BESS
- **2.** Except as otherwise expressly provided for herein, the Agreement shall continue in full force and effect in accordance with its terms.

IN WITNESS WHEREOF, the Parties may cause this Amendment to be executed in several counterparts, each of which shall be deemed an original but all shall constitute one and the same instrument.
