AMENDMENT ONE TO ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT

This Amendment One ("Amendment One") to the Pondera King Power Project Electric Reliability Council of Texas Standard Generation Interconnection Agreement, (the "SGIA") that was originally entered into between Pondera Capital Management GP, Inc. and CenterPoint Energy Houston Electric, LLC, executed October 8, 2010, is made between **PONDERA CAPITAL MANAGEMENT GP, INC.** ("Generator"), a Delaware corporation, and **CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC** ("CenterPoint Energy" or "TSP"), a Texas limited liability company, (collectively, "the Parties"), on this <u>30th</u> day of <u>Sencery</u>, 2013. In consideration of the mutual promises and undertakings herein set forth, Generator and CenterPoint Energy agree as follows and to amend the SGIA as stated below:

- 1. The NTP Need Date specified in Exhibit "B", section 2) is changed to "February 1, 2014."
- 2. The "Secured Cost" specified in Exhibit "E", 1)A) is changed to "\$41,600,000.00."

Except as modified by Amendment One, the provisions of the SGIA will continue in full force and effect in accordance with its terms.
