Attached, please find the Assignment and Assumption Agreement between Rattlesnake Wind I LLC ("Rattlesnake II") and Rattlesnake Wind II LLC ("Rattlesnake II") (the "Assignment"), as well as an explanatory letter from Rattlesnake II regarding the Assignment, for filing at the Public Utility Commission of Texas ("PUCT") pursuant to Substantive Rule 25.195(e). This Assignment pertains to that certain Generation Interconnection Agreement relating to Rattlesnake I's Phase 2 Plant, dated as of June 28, 2013 and filed with the PUCT on July 9, 2013, as amended by that certain First Amendment to Generation Interconnection Agreement dated as of August 18, 2014 and filed with the PUCT on September 16, 2014 (the "Interconnection Agreement"). This Assignment is permitted under Section 10.17 of the Interconnection Agreement.

The Assignment does not create any deviations from the Standard Generation Interconnection Agreement. However, certain details included in an exhibit to the Interconnection Agreement have been amended in connection with the Assignment, specifically Exhibit "D" Notice Information, as reflected in the replacement Exhibit "D" enclosed.

As we previously notified you by letter dated October 16, 2014, and as reflected in the fully-executed copy of the Agreement (attached hereto as Exhibit A), Rattlesnake I assigned to Rattlesnake II and Rattlesnake II assumed all of the rights and obligations related to that certain Phase 2 interconnection queue position number 13INR0020b, arising under that certain Generation Interconnection Agreement ("GIA"), dated June 28, 2013, by and between Rattlesnake I and WETT.

ASSIGNMENT AND ASSUMPTION AGREEMENT

This ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Agreement") is made effective as of October 16, 2014, by and between Rattlesnake Wind I LLC f/k/a CPV Rattlesnake Den Renewable Energy Company, LLC, a Delaware limited liability company (the "Assignor"), and Rattlesnake Wind II LLC, a Delaware limited liability company (the "Assignee").

WHEREAS, Assignor and Wind Energy Transmission Texas, LLC, ("WETT") are parties to that certain Generation Interconnection Agreement, dated June 28, 2013 (the "Interconnection Agreement"), pursuant to which WETT will interconnect Assignor's generation facility to WETT's transmission system; and

WHEREAS, Assignor and Assignee now desire that Assignor assign its rights and obligations under the Interconnection Agreement to Assignee in accordance with the terms hereof.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and intended to be legally bound, Assignor and Assignee hereto agree as follows:

- 1. <u>Conveyance and Assignment</u>. Effective as of the date hereof, Assignor hereby assigns and conveys to Assignee, all right, title and interest of Assignor in and to the Interconnection Agreement.
- 2. Acceptance and Assumption. Assignee hereby accepts the aforesaid assignment and conveyance of Assignor's right, title and interest in and to the Interconnection Agreement set forth in Section 1 above, and Assignee covenants and agrees that, effective as of the date hereof, it shall at all times, be bound by, observe and perform all of the duties and the obligations to be observed and performed by the Assignor under the Interconnection Agreement, to the same extent as if the Assignee had been a party thereto in place and stead of the Assignor.
