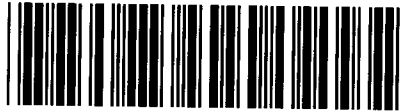

AMENDMENT ONE TO ERCOT STANDARD GENERATION INTERCONNECTION AGREEMENT

This Amendment One ("Amendment One") to the Electric Reliability Council of Texas Standard Generation Interconnection Agreement, (the "SGIA") that was originally entered into between Friendswood Energy Genco, LLC (identified at the time as Friendswood Energy Generation, LLC) and CenterPoint Energy Houston Electric, LLC, executed November 13, 2013, is made between **FRIENDSWOOD ENERGY GENCO, LLC** ("Generator"), a Texas limited liability company, and **CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC** ("CenterPoint Energy" or "TSP"), a Texas limited liability company, (collectively, "the Parties"), on this 4th day of MARCH, 2015.

In consideration of the current circumstances whereby: (1) Generator is in discussions with Quantum Utility Generation, LLC ("Quantum") to assume ownership of Friendswood Energy Genco, LLC; (2) Quantum is considering plans to construct a generation plant of a different design than originally contemplated in the SGIA; and (3) CenterPoint Energy is currently conducting a re-study of the interconnection requirements for the generating plant, Generator and CenterPoint Energy agree to amend the SGIA as stated below:

1. The NTP Need Date specified in Exhibit "B", section 2) is changed to "March 1, 2015."

Except as modified by this Amendment One, the provisions of the SGIA will continue in full force and effect in accordance with its terms.
