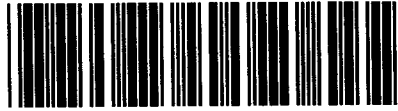

**NOTICE OF CONFIDENTIAL RESPONSES OF THE CITY OF GARLAND TO CREZ
TRANSMISSION PLAN PROPOSAL**

I, Lambeth Townsend, attorney for the City of Garland, Texas whose municipally owned electric utility operates under the name Garland Power & Light ("Garland") do hereby state:


1. I have reviewed the portions of the Direct Testimony of Dan D. Lanning filed in support of Garland's CREZ Transmission Plan Proposal ("CTP Proposal") for which Garland is asserting a claim of confidentiality.

2. The portions of the CTP Proposal for which a claim of confidentiality is made by Garland contain financial information that would provide, if disclosed, advantages to existing and future competitors. Garland adopted Resolution No. 9160 on July 20, 2004, in which it defined certain categories of information as competitive matters. Garland's determination of "competitive information" in Resolution No. 9160 includes, but is not limited to, financial information related to strategic and business plans. The information withheld reasonably relates to items classified as competitive matters as defined in the resolution.

3. I find Garland's claim that this information is confidential to be reasonable, and I believe that the information claimed is confidential.


