As with any utility, Tejas' O&M costs will be part of its revenue requirement. Tejas expects to recover its reasonable and necessary costs through rates.

Does Tejas plan to include these costs in its transmission cost of service that it plans to recoup from ERCOT load?

Response: Tejas and Babcock & Brown have not determined that Tejas will bear a portion of Babcock & Brown's cost for office space, office personnel, equipment, supplies, utilities, insurance and other operating costs. Although arms' length contracts have not yet been negotiated, Tejas anticipates that Babcock & Brown would charge hourly fees for time worked to provide advisory services, corporate oversight, and A&G services and that such costs will be determined reasonable and necessary and recoverable in rates.
