

REQUEST:

In reference to Ms. Camp's Exhibit JHC-3, 2007 Montague Fire Damage Claim in the amount of \$3,000,000, please provide a breakdown of costs by category totaling the claim damage amount. For any cost greater than \$10,000, provide the supporting invoice or work order.

RESPONSE:

The following response was prepared by or under the direct supervision of R. Keith Pruett and Jeanne H. Camp, the sponsoring witnesses for this response.

The following information is provided subject to further negotiation with the requesting party. In lieu of the requested information, the information being provided consists of all invoices and work orders that exceed \$10,000.

The information and documentation requested are voluminous and confidential. As a result, they will be made available only after execution of a certification to be bound by the protective order in this docket. An index of the voluminous and confidential documents is included in Attachment 1. Oncor would note that commercial insurance covers all costs in excess of \$3,000,000.
