GRANTING SOUTHWESTERN PUBLIC SERVICE COMPANY'S MOTION TO CONSOLIDATE, SET A PROCEDURAL SCHEDULE, AND FOR LEAVE TO FILE SUPPLEMENTAL TESTIMONY

I. INTRODUCTION

On October 3, 2008, Southwestern Public Service Company (SPS) filed a motion to consolidate the dockets listed above, proposed a procedural schedule for the energy efficiency (EE) phase of the rate case, and requested leave to file supplemental testimony in SOAH Docket No. 473-08-3436 (PUC Docket No. 35763) to address recovery of EE costs. No party filed objections to the motion. The Administrative Law Judges (ALJs) find the motion and requests to have merit.

II. ORDER

The motion is granted. The above listed cases are consolidated, the procedural schedule set forth below is adopted for the EE phase of this docket, and SPS is granted leave to file supplemental testimony and schedules in SOAH Docket No. 473-08-3436 (PUC Docket No. 35763) to address recovery of EE costs.
