To Whom It May Concern:

Please accept for filing in the above-referenced project the Performance Measures Retail Electric Market Report for Texas Retail Energy, LLC ("TRE") for calendar year 2009. TRE is a retail electric provider ("REP") operating under REP Certificate No. 10065, originally issued to TRE's predecessor, Creed Power Company, LLC in PUC Docket No. 29168. In accordance with Schedule B of the instructions for REPs contained in the document "Filing Requirements for Performance Measures Reporting Pursuant to P.U.C. SUBST. R. 25.88," TRE is providing the following information:

• Measure A-1: Customers Served by REPs – This information is provided in copies of the EIA-826 form submitted by TRE to the Energy Information Administration ("EIA"). These documents are being filed separately as confidential information pursuant to P.U.C. PROC. R. 22.71. Electronic copies of the documents are not being filed because P.U.C. PROC. R. 22.71(d)(3) prohibits electronic filing of confidential documents unless specific arrangements are made and agreed to on a case-by-case basis and no such agreements have been made in this instance.

The documents contain Highly Sensitive and Confidential information that is protected from public disclosure pursuant to the provisions of Chapter 552 of the Public Information Act. TEX. GOV'T CODE ANN. § 552 (Vernon 2004). The confidential, Protected Material is exempt from public disclosure pursuant to Section 552.101 of the Public Information Act because it is confidential under regulations adopted by the Department of Energy at 10 CFR 1004.10. Additionally, the confidential, Protected Material is exempt from public disclosure pursuant to Section 552.110(b) of the Public Information Act because it contains confidential, trade secret information and disclosure of the Protected Materials would give an undue advantage to Texas Retail Energy, LLC's competitors in the highly competitive REP market.

Pursuant to Order No. 4 in PUC Docket No. 29168, TRE is only authorized to serve one customer, its affiliate Wal-Mart Stores, Inc.
