Dear Mr. Galloway:

Please accept the Performance Measures for Retail Electric Market Report for the second quarter 2013, prepared by MidAmerican Energy Company (MidAmerican) for filing in the above-referenced proceeding. As specified in the rules, the measures required for retail electric providers (REPs) are:

- Measure A-1 Customers served by REPs
- Measure C Technical Field Performance

MidAmerican was certified to do business as a Retail Electric Provider in the fourth quarter of 2008, however served no customers in Texas until the first quarter of 2009. MidAmerican is submitting confidentially, under Procedural Rule 22.71, the information required in the two measures set forth above. Please note, that in connection to Measure A-1, which requires both paper and electronic filing of Department of Energy EIA Form 826 reports, MidAmerican has submitted only paper copies of these reports because it considers these reports to constitute confidential information.

Procedural Rule 22.71 provides that a party shall not file confidential materials electronically unless specific arrangements are made and agreed to by the parties involved on a case-by-case basis. MidAmerican is unaware of any such arrangements having been made. Accordingly, MidAmerican is not filing the EIA Form 826 reports electronically at this time. However, should staff desire to review electronic copies of these reports, MidAmerican will discuss appropriate arrangements for filing such materials in consideration of this rule.

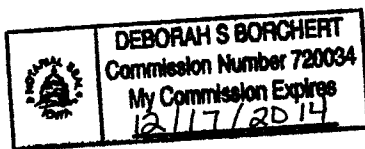
