

To Whom It May Concern:

In accordance with P.U.C. Substantive Rule § 25.53, Luminant Generation Company LLC, Big Brown Power Company LLC, Oak Grove Management Company LLC, Sandow Power Company LLC, Tradinghouse Power Company LLC, and Valley NG Power Company LLC (collectively "Luminant Power") hereby file a revised comprehensive summary of their Emergency Operations Plan ("EOP"), along with this letter and the affidavit required by subsection (c)(2)(F).

Luminant Power contends that the revised comprehensive summary of the EOP contains confidential, security-sensitive information that should be maintained as confidential in the Commission's files and should be considered exempt from disclosure to the public pursuant to §§ 552.101 and 552.110 of the Texas Government Code. This is sensitive commercial and trade secret information about Luminant Power's business that, if disclosed to competitors, would cause substantial harm to Luminant Power and disadvantage it with respect to its competitors. The revised comprehensive summary of the EOP has therefore been filed under seal.
