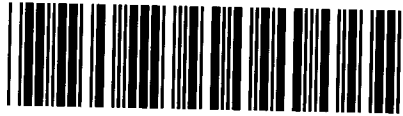


Dear Madam or Sir:





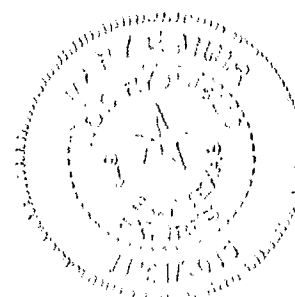
1. My name is L. Wayne Morton. I am the General Manager for Wind Energy Transmission Texas, LLC ("WETT").


