AB-1-1	Please identify the route and the link or segment of that route on which your property is located.
AB-1-2	If you are not the only owner of your property affected by Oncor's proposed transmission line, please identify the other owner(s).
AB-1-3	Please describe (1) where on your property each house, barn, or other improvement is located, (2) where it is located in relation to the proposed transmission line, and (3) its distance from the proposed transmission line.
AB-1-4	Are your property boundaries represented accurately on the maps provided by the utility? If not, please explain any discrepancies.
AB-1-5	What is the primary use for the property you own that will be impacted by the proposed transmission line?
AB-1-6	In your opinion, is there any feature about your land that you believe would impact the development of a transmission line on your property? If so, please explain.
AB-1-7	What are your specific concerns about the proposed transmission line?
AB-1-8	If you object to any route Oncor has proposed based on a possible adverse effect it would have on your property, please (1) list each of those adverse effects, (2) describe in detail exactly how your property will be affected, and (3) if the adverse effect is primarily economic, please so state. Please provide or identify any documents that support your objection.
AB-1-9	Did you attend any open houses presented by the utility concerning this proposed transmission line? If so, when and where? Did you provide written comments at or after the open house?
AB-1-10	What specifically do you propose as a solution to your concerns in this docket? If a solution would be routing the transmission line along another part of your property, please describe as closely as possible where you propose the route should run.
