I am the Executive Director of Butman Methodist Camp & Retreat Center in Mulberry Canyon, south of Merkel, Texas. Please accept this letter as request to intervene in opposition to Segment "E" of the proposed Sweetwater East-Central Bluff 345kV Transmission Line Project.

Butman Methodist Camp & Retreat Center is a ministry of the Northwest Texas Annual Conference of the United Methodist Church, and we host groups from across Texas and beyond throughout the year. We have two Chapels, two Lodges, four Conference Rooms, seven Cabins, four Cottages, Dining Hall, Recreation Center, ropes challenge course, swimming pool and four to five families with eight children residing at the Camp year round. Many of our guests are children and youth who visit us with their church group, their school group or their scout group.

Proposed transmission line preliminary link "E" would apparently run across our main entrance, and would be in the foreground of the Camp's recreation areas. As you know, many people believe that these transmission lines are potentially hazardous to children, youth and adults because of the electromagnetic fields which they may create. We are seriously concerned about the perception of the public regarding these transmission lines, and fear that the presence of these lines would discourage many groups from visiting our youth camp and retreat center.

In addition, we feel we would be burdened with trying to protect the towers in order to reduce any possible liability exposure. We could incur additional liability insurance premiums as a result of the towers' presence near the camp. This would impose a serious detriment to our ministry and to the camping and retreat revenues of the Camp.

Also, The Board of Trustees has been considering an expansion to the camp facilities of over \$2.0 million. However, because of the uncertainty of the effect a transmission line may have on the camp the decision has been postponed pending the resolution of this issue.

I am opposed to Segment "E" of the proposed Sweetwater East-Central Bluff 345kV Transmission Line Project and I strongly urge you to consider an alternate route which is not within or near this park and recreational area for children, youth and adult camping and retreat groups.

We are members of the board of directors of the Butman Methodist Camp and Retreat Center. Please accept this letter in opposition to segment "E" of the proposed Sweetwater East to Central Bluff 345kV Transmission Line Project.

Butman Methodist Camp and Retreat Center is a ministry of the Northwest Texas Annual Conference of the United Methodist Church, and we host groups from across Texas (and even outside of the State) throughout the year. There are two chapels, a number of lodges, several conference rooms, a dining hall, lodging for 336 guests and a recreation center on our campus and, as you can imagine, many of our guests are children and teenagers who visit as part of a school, church or youth group. We also have four families residing year round on our campus.

The transmission lines would apparently run right across our main entrance, and would be in the foreground of the recreation areas of the camp. As you know, many people believe that these transmission lines are potentially hazardous to children because of the electromagnetic fields which they may create. We are concerned about the perception of the public with regard to these lines, and fear that the presence of these lines may discourage some groups from attending our camp.

In addition, we worry that the transmission towers may prove to be an attractive nuisance for some of our campers, and we would be burdened with trying to protect the towers in order to reduce any liability exposure.

We are against proposed Route "E" and would urge you to consider a route which is not within this park/recreational area.

Also, The Board of Trustees has been considering an expansion to the camp facilities of over \$2.0 million. However, because of the uncertainty of the effect a transmission line may have on the camp the decision has been postponed pending the resolution of this issue.

I am very surprised that my Representative would allow Segment "E" to continue when the placement of this transmission line would harm the constituents you serve, and could undoubtedly harm a viable business and ministry over 50 years old, when there are acceptable alternate routes available. While I know Butman Camp is a Christian nonprofit organization and we do not pay taxes on our camp, I also know that our payroll in 2008 was over \$385,000 and is projected to be over \$400,000 this year. In 2008 we purchased another \$325,000 in equipment, supplies and materials, most of which is bought locally in the Abilene, Merkel and Sweetwater area.

! am opposed to Segment "E" of the proposed Sweetwater East-Central Bluff 345kV Transmission Line Project and I strongly urge you to consider an alternate route which is not within or near this park or recreational area.

We are seriously concerned about the perception of the public with regard to these transmission lines, and fear that the presence of these lines would discourage many groups from our camp & retreat center.

In addition, we would be burdened with trying to protect the towers in order to reduce any possible liability exposure. We could incur additional liability insurance premiums as a result of the towers presence.

Also, The Board of Trustees has been considering an expansion of the camp facilities, approximately \$1.5 million to \$2.0 million but because of the uncertainty of the effect a transmission line may have on the camp this decision has been postponed until this issue is resolved.

I can not accept that a representative of the people to whom you serve would allow the placement of a transmission line which couldcause harm or damage to a business, a ministry and your constituents, when acceptable alternative routes are available.

I am against proposed Route "E" and would urge you to consider a route which is not within this park or recreational area.
