2. On October 28, 2009, LCRA Transmission Services Corporation (LCRA) filed an application to amend its certificate of convenience and necessity for a transmission line in Gillespie, Llano, San Saba, Burnet and Lampasas Counties. This is identified as the Gillespie to Newton Project.

3. O’Ryan owns property in Llano County known as the Paradise Ranch. Proposed link C7 crosses O’Ryan’s property. Link C7 is located within three alternate routes – GN1, GN2, and GN3. Additionally, there are habitable structures located on O’Ryan’s property that would be affected by the location of alternate routes that include link C7.
