ORDER NO. 9

On December 22, 2009, the Staff of the Public Utility Commission of Texas (Staff) filed its Motion to Compel Responses to Staff's Second RFI to Intervenors. The following parties filed responses in opposition to the motion to compel: Landowners' Preservation Group (LPG), Yancey Creek Ranch, Bob Koehler, and Hilton Hopson.

That motion to compel is **GRANTED** with regard to the following intervenors: Julia Crenwelge, Enchanted View Ranch, L.P., David Friedberg, Patricia Harper, John Harris, Ferdinand Hoepner, Erin Howard Mitchell, Marianne Parker, the Railroad Commission of Texas, Jean Renfro, Curt Rhodes, Peter Scholl, Terry Spicer, Mark Sutton, Lindsay Harris Swenson, Virginia Terrill, Olney Wallis, Thomas K. and Billy C. Terry, Charles Lancaster, Van Martin *et al.* Partnership, Lynette and Charles Lawson, George Roland Lang, David Smith, Mackey Bozarths, Glenda Shoemaker, Bill and Anita Wappler, Troy Wappler, and Ronald Griffin. This list includes individual intervenors, intervenors that are members of Starr GM Endeavors, LP, and one member of LPG.

Those intervenors' responses to the Second RFI shall be filed no later than January 7, 2010.

The motion is **DENIED** with regard to the remaining intervenors named therein, either because those intervenors have filed answers to the RFI or it is unclear whether the

intervenors were properly served with the RFI and motion (see the Landowners Preservation Group's response, page two).

Although the Administrative Law Judge will rule soon, no order will be issued this week regarding Yancey Creek Ranch's Motion to Compel, CJ Ranch's Motion to Compel, the re-titled LPG's Motion to Compel LCRA to Respond to LPG's First, Second and Third RFIs, or KDCB Garrett Ranch, Ltd.'s Motion to Abate. If the motions to compel ultimately are granted, those parties may request the opportunity to supplement their testimony for good cause, subject to objections.
