This Oncor 345kv transmission line will greatly affect the aesthetic value of our ranch as well as the property value. We already have existing (LCRA) transmission lines running across our property and absolutely don't want to give any more of our land up for an easement. Our deer, turkey and quail population will be affected as well as nesting areas for various bird species. The School Creek headwaters start just above our ranch, and there are many natural springs that provide additional wildlife habitat that would be affected not to mention erosion problems. Many oaks have died due to oak wilt and much of our healthy 100 + yr old oak trees would be wiped out in the direct pathway of the transmission proposal. The waves of the power lines could effect the production of our cattle ranch that we DEPEND on for income and we have read that there are studies about health effects on children (we have 3). This ranch isn't something that was given to us by ancestors. We've worked very hard for this ranch and do not believe that a private entity has any right to any part of it. We are on the alternative and preferred route, but if this project is a must, it must go along the alternative route (which is TT and EE) where there are less homes and less of our property that will be so greatly impacted. I understand that if this does come thru, the monopoles are a must on either route.
