LAURANCE KRIEGEL'S RESPONSE TO "CROSS TEXAS TRANSMISSION,
LLC'S SECOND REQUEST FOR CLARIFICATION"

NOW COMES, Laurance Kriegel, requesting all information and questions sent in by all persons involved in this proceeding be answered in detail.

NOW COMES, Laurance Kriegel, stated the Public Utility Code allows one person to present information to the Public Utility Commission of Texas to request all rates of electricity be affordable and reasonable.

Cross Texas has not answered any question as to the electricity they will receive into there proper Transmission Line to show this electricity is affordable and reasonable nor have they submitted information to show their alternate energy produced electricity will be the same electricity as is produced by the conventional electric power company's.

Laurance Kriegel has enclosed in previous responses information from the State Comptroller Office of Texas showing Cross Texas Transmission, LLC and LS Power Development, LLC does not have their Officers and Directors recorded with the State Comptrollers Office, Therefore these two companies may not have a charter recorded with the Attorney's General's Office or State Comptroller's Office. Without these conditions being met these two companies do not have standing to conduct business in Texas. Therefore their application has deficiencies.

The State Comptroller's Office Franchise Tax report shows Not in Good Standing for Cross Texas Transmission, LLC on 4-30-2010.

Cross Texas has not answered any of the questions submitted by Laurance Kriegel. For Cross Texas to be upholding the Law they should send the Public

Utility Commission of Texas a Charter of the company, and a list of there Board of Directors of the company. Without this information in the State Comptrollers Office this company does not have legal standing to conduct business with anyone.

Does the proposed Electric Wind Mills electric this transmission line is proposed to carry meet all of the Electric Energy requirement established by the United States Code of Regulations for transmission or service to a customer, citizen?

The main questions to answer are: What is the hertz value to be received from a Electric Windmill to be sent through these transmission lines?

What is the Voltage? Will the Voltage remain constant enough with the varying wind speeds to have a stable Voltage in the line for service to a customer, citizen? What problems will a unstable Voltage or Hertz value have on a customers electric motor or lighting in a home? Low Voltage will blow fuses. Low Voltage will burn up a electric motors.

What is the Amperage produced by the Electric Windmill Company planning to send this Electric charge into the proposed Electric Transmission line? Does this electricity meet the United States Code of Regulations for electricity sent through Transmission lines?

Does Cross Texas Transmission or LS Power Development have there electric service provider number with the Public Utility Commission of Texas?

At the present time the American Wind Association is stating Electric Windmill Electricity with be about \$500 KWH. This is excessive and a citizen can not afford to pay this price for electricity.

The excessive price does not establish a need for a new Transmission Line or Electric Windmill Companies.

Laurance Kriegel is the owner of Lands on a General Land Office Map with his footprint on it dated about 1948 or 1949 with my Fathers and Mothers name on it. This map has Laurance Kriegel's initial's on it. This map number may be A-7-13 and other maps may be of record for myself or my Mother or Father.

This map may contain most of the 3,050,000 acres used to build the Capital of Texas.

One or more of the proposed routes may cross my property.

Please help Laurance Kriegel obtain my ownership Maps from the General Land Office of Texas. Then correct discussions can be made.

Cross Texas states they have checked with the county tax offices in the area of the proposed alternate energy electric lines. Tax records are not the official recording system for fee simple land ownership of property for a correct signature for a Right of Way. The Law allows one person to Intervene on behalf of all citizens in Texas or under a proposed Transmission Line.

Other landowners in the proposed area of These Transmission lines may also need to have the correct map from the General Land Office of Texas for a correct Right Of Way.

Has the CREZ information document's submitted by Cross Texas Transmission, LLC and LS Power Development, LLC been approved by the Governor of Texas?

These Alternate Energy Route's and Plans are not competitive to allow for a rate reduction.

Are these Alternate Energy Route's planning on receiving the same quality of electric as the conventional power Plants produce?


