

**COMMISSION STAFF'S STATEMENT REGARDING PROTECTED
MATERIALS IN COMMISSION STAFF'S RESPONSE TO THE HENRY
FAMILY'S APPEAL OF ORDER NO. 9**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission) representing the public interest, and files this Statement Regarding Protected Materials in Staff's Response to the Henry Family's Appeal of Order No. 9 in compliance with the Protective Order adopted in Order No. 2 of this docket (Protective Order).

On July 29, 2010, Staff filed its redacted Response to the Henry Family's Appeal of Order No. 9 (Response). Staff's Response refers to the ABB analysis and material in the transcript of the July 12, 2010 hearing that has been designated by Oncor as Highly Sensitive Protected Material under the Protective Order. To maintain the protection of information that Oncor has designated as Highly Sensitive Protected Material, Staff has redacted portions of the Response containing information designated as Protected Materials under the terms of the Protective Order.

The undersigned counsel has reviewed the information described above and has found in good faith that the documents contain materials that Oncor has previously designated as Highly Sensitive Materials information that is exempt from disclosure and that merits the "Protected Materials" designation.


