- 1-5 Please provide any and all of Oncor's files regarding Marvin Tyson or his property.
- 1-6 Please provide any and all of Oncor's files regarding the Gray Wynn Klein Ranch or any of its owners.
- 1-7 Provide copies of any data or research collected by or for Oncor related to potential security or reliability concerns of locating segment K3 in parallel to an aging pipeline conveying high-pressure volatile fuels, or paralleling CREZ lines along pipelines in general.
- 1-8 Provide copies of any data or research collected by or for Oncor related to the likelihood of a single event destroying or incapacitating parallel CREZ lines.
- 1-9 Provide copies of any data or research collected by or for Oncor related to the optimum distance for spacing CREZ lines to reduce the likelihood of a single event destroying or incapacitating parallel CREZ lines.
- 1-10 Provide copies of any data or research collected by or for Oncor related to difficulties in routing a segment along Highway 287 on the stretch between the towns of Jolly and Bellevue.
