# RESPONSE OF PALO PINTO COUNTY MUNICIPAL WATER DISTRICT NOT (INTERVENOR) TO REQUEST FOR INFORMATION

Staff 1-1 Do you have a habitable structure (According to Subst. Rule 25.101, a habitable structure is a structure that is normally inhabited by humans or intended to be inhabited by humans on a daily or regular basis.) near one or more of the segments of the proposed transmission line? If so, describe the structure, identify the segments(s) and estimate how far the proposed line is from the habitable structure.

ANSWER: No.

Staff 1-2 Will one or more of the segments of the proposed transmission line cross your property? If so, identify the segments and any features including but not limited to a property line, pipeline, power line or road that the proposed transmission line will follow through your property.

ANSWER: The proposed transmission line appears to follow an existing BEPC electric transmission line to the North of the Town of Gordon which passes through the water shed of the Intervenor's Municipal Water Supply Lake Palo Pinto.

Staff 1-3 Do any existing transmission or distribution lines cross your property? If so, please describe how and where they cross your property.

ANSWER: There are BEPC electric transmission lines adjacent to Lake Palo Pinto which pass through the water shed area to Lake Palo Pinto which is operated by Palo Pinto County Municipal Water District No.

1. Location of line shown on Exhibit A. Exhibit A also shows the location of proposed Turkey Peak Reservoir. The Water District has spent considerable sums in planning for this reservoir which will be constructed as soon as all planning and permitting is completed which will be several years from now.

The existence of another electric transmission line through the proposed lake area, should the present application of Lone Star result in such relocation, would be of disastrous cost to the Water District.

Staff 1-4 Are any existing transmission or distribution lines visible from your property? If so, please describe them from where the lines are visible, approximately how far away the lines are located and how the current lines affect your property, if at all.

**ANSWER:** The existing transmission lines are shown on attached Exhibit A made a part hereof and included herein.

Staff 1-5 Do you currently have any windmills located on your property? If so, please describe the location of the windmills and how many are located on your property?

ANSWER: No.

Staff 1-6 Are you aware of any Affected Landowner that did not receive notice of the proposed transmission line project from Lone Star? If so, please identify the landowner and describe as best possible the location of the property affected.

ANSWER: No.

Staff 1-5 Have you discussed any modifications to the proposed transmission line route on your property with a representative of Lone Star? If so, what were the modifications to the proposed route that you suggested and what was the response of Lone Star?

ANSWER: Palo Pinto County Municipal Water District No. 1 is not concerned about the location proposed for the transmission line, but if through hearings on the proposed transmission line, it should be determined that the relocated transmission line would pass through or over either Lake Palo Pinto or the proposed Turkey Peak Reservoir, then it would be of material concern to the Water District. If the Water District can receive assurances from the Applicant or the PUC that no changes to the location of the line will be made that will cross either the existing Lake Palo Pinto or the proposed Turkey Peak Reservoir, it will no longer be necessary for the Water District to participate in these proceedings.

Staff 1-5 Did you attend any open houses presented by Lone Star concerning this proposed transmission line? If so, when and where? Did you provide written comments to Lone Star at or after the open house?

ANSWER: No.


