

**SOAH ORDER NO. 5
ADOPTING PROCEDURAL SCHEDULE; NOTICE OF HEARING AND
SETTLEMENT CONFERENCES;
INTERVENTION RULINGS AND REQUIREMENTS;
CHANGE IN SERVICE REQUIREMENTS**

On July 9, 2010, the undersigned Administrative Law Judge (ALJ) held a prehearing conference in this matter in Austin, Texas. Lone Star Transmission, LLC (Applicant) and the Staff of the Public Utility Commission of Texas (Commission) entered formal appearances. A large number of intervenors also attended.

I. PROCEDURAL SCHEDULE

In order to remain as an intervenor in this case, you must do more than fill out the initial form requesting intervention. **On or before August 16, 2010**, you must file either a statement of position or testimony. If you do not file either a statement of position or testimony, you will be dismissed from this case. Either a statement of position or testimony must be properly filed with

¹ The agreement of the parties is that as part of Applicant's rebuttal, Applicant is required to file all workpapers and other materials relied upon to prepare the testimony.

² Depositions must be requested no later than noon on September 1, 2010.

³ The 180th day is Saturday, November 20, 2010. The Commission must enter a final order on or before that date. Based on CREZ precedent, the parties expect the Commission would target Friday, November 19, 2010, as the final workday on which an order could be issued.

the Commission or PUC filing clerk.⁴ For testimony and statements of position, the Commission's rules require a party to file 13 copies of documents with the Commission's filing clerk.⁵ Both the PUC and SOAH docket number must be written at the top of the first page.⁶

II. NOTICE OF HEARING

The hearing on the merits in this matter will convene at **10:00 a.m. the first day, September 7, 2010, and 8:00 each day afterwards**, in Austin, Texas, and will continue day to day until concluded. The parties anticipate that the hearing will last at least seven days.⁷ The hearing will be held at:

The ALJ will not convene a separate prehearing conference—such matters will be addressed at the hearing before evidence is taken. The Applicant will put on its direct case, Intervenors will put on their cases according to the segment of the line, Staff will put on their case, and then Applicant will put on its rebuttal.

IV. EVIDENCE AND EXHIBITS

A. Testimony or Statements of Position

Pursuant to P.U.C. PROC. R. 22.124(a) and as noted above, intervening parties must either file written direct testimony or a statement of position by **August 16, 2010**. A statement of position clarifies a party's position but is not evidence. Testimony is generally offered as evidence and must conform to the Texas Rules of Evidence. For example, if the witness is not an expert, the testimony must be based on the witness' personal knowledge. *See* TEX. R. EVID. 602, 701, and 702. **Any intervening party that fails to file written direct testimony or a statement of position by August 16, 2010, is subject to dismissal from the case.**

In this proceeding, Applicant has described multiple alternate routes that the proposed transmission line may ultimately follow. One of those routes has been designated by the Applicant as its "preferred route." Parties are cautioned that this designation carries no significance in the decision-making process. Applicant has stated that any one of the routes proposed would meet the statutory and regulatory criteria. It is the duty of the ALJ and, ultimately, the Commission to choose the route that best meets those criteria. Any proposed route, or any combination of properly noticed proposed routes, could be selected. It is the duty of the parties to provide the decision-makers, via written direct testimony or statements of position, the information needed to reach a just and reasonable decision as to the appropriate route.

B. Exhibits Offered into Evidence at the Hearing

Exhibits will be marked in advance *by the court reporter* and will have the correct number of copies for distribution. The party submitting the exhibits will have responsibility for complying with this order. The pages of any multi-page exhibit will be numbered consecutively. Please arrive early (no later than 9:30 a.m.) on the date of the hearing to allow time for the court reporter to prepare.

At the time a party offers *prefiled testimony* into evidence for its direct case, it will provide **two copies** to the court reporter and **two copies** to the ALJ. With respect to *exhibits* offered, the party will provide **two copies** to the court reporter and **three copies** to the ALJ. For all documents (exhibits) that are **not** prefiled, parties are also required to furnish a copy of such to other parties who are attending the hearing.⁸ Two of the copies provided to the ALJ will be used in preparing the administrative record in the event the Commission's final order in this case is the subject of judicial review. Therefore, the copies must conform with any changes or corrections that are made to the official exhibit.

Demonstrative exhibits that are used at the hearing and that are otherwise admissible in evidence will not be placed in the record if their admission would unduly burden the record. Parties instead may submit photographs that fairly and accurately represent such exhibits, for admission into evidence. Copies of photographs will be provided by the sponsoring party to all other parties participating in the hearing.

C. Information for Court Reporter

At the start of the hearing, each party will provide the court reporter with the following information:

1. A list of the party's witnesses with the correct spelling of the witnesses' names and a contact phone number for each witness.
2. The name and address of the representative for that party.
3. A glossary of technical terms and acronyms referenced in the party's testimony, if such has been prepared or is available.

D. Objections

Parties wishing to object to questions or answers during live examination should state concisely the grounds of the objection. Untimely objections will be overruled. Oral argument concerning discussion of an objection will be limited to the party or parties making the objection and the party or parties against whom the objection is directed, unless the ALJ extends a broader invitation for argument.

To clarify the record or assist in understanding the evidence and issues, the ALJ may ask questions of witnesses at the hearing. On occasion, counsel might be concerned that the phrasing of such a question might cause problems (such as ambiguity or inquiry into privileged information) of which the ALJ is unaware. Counsel should voice such concerns just as they would object to questions by other counsel.

On or before July 21, 2010, Intervenors on the above list shall file a statement indicating how the proposed transmission line will affect their property. For example, if an intervenor

received notice of the transmission line, please indicate the number of your property tract on the notice. Additionally, Ray Jenkins III, Randy Pack, and Steven Adams Titcomb have withdrawn as Intervenors.

Except for the intervenors listed above and those who have withdrawn, all intervenors who have filed a request to intervene on or before July 9, 2010, are admitted as parties. Attached is a current service list. If there are any errors, please contact the ALJ's assistant at norma.lopez@soah.state.tx.us or 512-936-0712.

VI. SERVICE OF PLEADINGS

The Commission's rules and previous orders in this case required all parties to "serve" (provide a copy of) that document to other parties by either email, fax, or mail, once a document was filed. However, in this matter, we have over 150 parties. Although the ALJ has requested all parties to furnish an email address to Ms. Norma Lopez at norma.lopez@soah.state.tx.us, approximately one hundred parties have not complied with this request. Given the large number of parties, the high cost of serving documents to all parties who have not provided email, and the accessibility of all documents via the internet on the Commission's interchange, **the ALJ no longer requires direct service of documents.** (This ruling does not apply to documents sent and received in discovery.)

Instead, after a document has been filed with the Commission, a party need only send a notification via email to dkt38230@soah.state.tx.us that a filing has been made.⁹ It is the responsibility of each party to check the Interchange daily for filings in this matter and adhering to any deadlines placed upon them by such filings. No later than July 21, 2010, parties who have not yet done so, must provide their email address to Ms. Norma Lopez at the email address stated above. If a party cannot access the internet or does not have an email address, they must notify Ms. Lopez via letter or phone at 512-936-0712, by that same date, July 21, 2010.¹⁰
