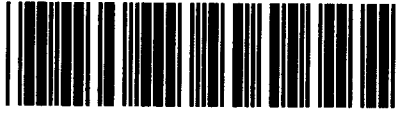

JOINT AGREED MOTION TO MODIFY THE PROPOSED ORDER


COME NOW, Rusk County Electric Cooperative, Inc. ("Rusk County") and on behalf of itself and Luminant Generation Company LLC ("Luminant"), Oncor Electric Delivery Company LLC ("Oncor"), and the Public Utility Commission of Texas Staff ("Commission Staff"), files this Joint Agreed Motion to Modify the Proposed Order.

The parties propose inserting the following as a new Ordering Paragraph Number 3 to the Proposed Order filed on May 3, 2011 and renumbering the subsequent paragraph accordingly:

Upon completion of the physical interconnection facilities, Luminant Generation shall cease providing electric service to Luminant Mining when (1) ERCOT provides notice to the Parties, to the extent required under the ERCOT Nodal Protocols and the ERCOT Operating Guides, that it has completed all necessary testing and verification, and (2) Rusk County notifies Luminant Generation and Luminant Mining that it is prepared to commence providing retail electric service to Luminant Mining. Notwithstanding the finality of this Order, Rusk County shall provide monthly Status Reports to the Commission beginning thirty days after this Order is signed.

WHEREFORE, PREMISES CONSIDERED, for the reasons stated above, the parties respectfully request that the Commission consider the proposed revision to the Proposed Order.


