
TO THE HONORABLE JUDGE KILGORE:

Pursuant to P.U.C. PROC. R. 22.124, intervenors Golden Spread Electric Cooperative, Inc. (“Golden Spread”) and Deaf Smith Electric Cooperative, Inc., Lamb County Electric Cooperative, Inc., Lighthouse Electric Cooperative, Inc., Rita Blanca Electric Cooperative, Inc., South Plains Electric Cooperative, Inc., and Swisher Electric Cooperative, Inc. 
