LAND OWNED BY ROSALIE MANN GREGG

The land I own has been in the family over 130 years. My grandfather, W. J. Mann, settled on it in the 1880's. He served the county as justice of the peace, when he was twenty years old; later became sheriff, and county commissioner. He, was one of those men involved in the establishment of Decatur Baptist College.

One of the proposed routes Oncor has designated as "J", would run through the center of my property, taking most of the meadow, which furnishes hay for one of my daughter's and her husband's cattle.

There are two gas wells that could cause a problem considering the fact should there be lightening strikes there could be a catastrophe.

Many Indian artifacts have been found in the area, since there is a spring in Garrett Creek on the north side of the property where they would have camped.

There are developments surrounding the land, which has increased the value of the property considerably, this line would render it of little value. The division of the property between my children would be most difficult with such monstrosities in the center. A granddaughter has already selected a site for her new home, cleared the land, planted trees, and established a ground tank. A small family cabin is located near an older ground tank.

We are also concerned as to what this would do to the health of the youngsters coming up.

As you can see, this land means a great deal to me and my family, not just the devaluation of it, but the defacing of something that is dear to our hearts.
