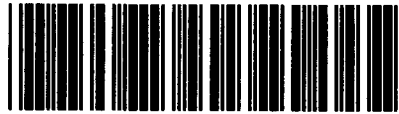

RE: WILLOW CREEK - HICKS 345 KV TRANSMISSION LINE

TO WHOM IT MAY CONCERN:

I am a single parent and own property within your proposed Route Segment J, Tract #71. I want to go on record with you that I strongly oppose your power line on and across my property. This line will in effect cut my property in half.

I have inherited this land from my parents and we have all worked long and hard to have the land that we have today. This land, and surrounding land, has been in my family for 4 generations and we, the collective family, still own and operate our cattle & crop farms on this same property. We all live and raise our families within the boundaries of property that your line will affect.

Your high voltage line would affect approx. 21 people in my family alone by running this through our properties. We are greatly concerned about the effects on the health of all of us and our offspring and our stock. Not to mention the other animals and bird life that exist in and around our property. We also have many pecan trees, and other trees, that will be destroyed by your transmission line.

Farming is a way of life here and is the rudiment of the food chain. We have many birds in our area that also share a basic responsibility for their part in the food chain. The environment and its effect on our cattle and these other animals is of great concern.

My property is also somewhat unique because I currently am in the process of receiving a historical designation for my property because it was where Machine Gun Kelly held a rich oilman from Oklahoma hostage at one time and has been written about in history books on Wise County.

All of this and the fact that my property value will GREATLY decline because of this unsightly monster being visible from all areas of my property. I have relied strongly on the idea that my retirement will be secure from the value I can place on my property and now that is in jeopardy by your plans and the actions you are considering.

PLEASE DO NOT allow this 345 KV transmission line to cross the land that me, my family, and my lifetime neighbors own. The effect this line would have on us is devastating.
