#### **QUESTION NO. 1-1**

SUBST R. 25.101(a)(3) defines "habitable structures" as follows: "Structures normally inhabited by humans or intended to be inhabited by humans on a daily or 'regular basis. Habitable structures include, but are not limited to, single-family and multi-family dwellings and related structures, mobile homes, apartment buildings, commercial structures, industrial structures, business structures, churches, hospitals, nursing homes, and schools."

#### **P-LINE INTERVENORS RESPONSE:**

#### **Donald Northcutt Partners Response:**

My property (640 acres) is located 8 miles south of Mason on US Highway 87. It is on the west side of the highway. I have approximately 4400 feet of frontage on the Llano River as my south boundary. The line follows an existing Right-of-Way, the AEP 138 kV line. The AEP runs northwest to southeast and crosses the river on the east side of my place.

We have built a new four bedroom home near the river in about the middle of the property. The existing Right-of-Way is about 500-600 yards from the house. We feel that the new line would detract from our view and have a very negative effect on the value of the property. We spend 50% of our time at this house.
