**APPLICATION FOR APPROVAL OF SETTLEMENT AGREEMENT
AND REQUEST FOR CORRECTION TO STYLE**

Staff of the Public Utility Commission of Texas (Staff) files this Application for Approval of Settlement Agreement and Request for Correction to Style and would show in support as follows:

Staff and Ambit Texas, LLC (Ambit or Company) (together, Parties) have entered into a Settlement Agreement (Agreement). The Agreement, previously filed separately in this docket, has been signed by representatives of both parties and includes a Proposed Order. This Agreement resolves and concludes the investigation of Ambit for violations of Sections § 17.004 and 39.101 of the Public Utility Regulatory Act¹ (PURA) as well as P.U.C. SUBST. R. 25.475 and 25.479, concerning customer protection rules for retail electric service.

Furthermore, the style of the Agreement and Proposed Order previously filed in this docket incorrectly reflect the name of Ambit Texas, LLC as Ambit Energy. Because the correct name is Ambit Texas, LLC, Staff requests that the style of this docket be corrected as displayed in this pleading.

WHEREFORE, Staff respectfully requests that its Application for Approval of Settlement Agreement be granted and the style of this docket be corrected.


