COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this proposed procedural schedule in response to the Notice Requesting Staff's Recommendation and would show the following:

On July 26, 2010, Oncor Electric Delivery Company LLC (Oncor) filed a Compliance Tariff pursuant to the Final Order in Docket No. 35718 requesting approval of reductions to the Discretionary Charges in its Tariff for Retail Delivery Service.

On July 29, 2010, the Commission's ALJ filed a Notice Requesting Staff's Recommendation requiring Staff to file a recommendation on the compliance filing or propose a procedural schedule on or before July 17, 2010.

Notice. P.U.C. PROC. R. 22.51(b) applies. Staff finds the content of Oncor's notice adequate and conforms to this rule. Pursuant to P.U.C. PROC. R. 22.51(b)(1) newspaper notice is not required.

Procedural Schedule. Staff proposes the following procedural schedule which provides a time for filing a recommendation following an intervention deadline.

Deadline for Oncor to file proof of notice	August 30, 2010
Deadline for intervention.	September 8, 2010
Deadline for intervenor requests for hearing and intervenor comments on the merits of the application if not requesting a hearing	September 13, 2010
Deadline for Staff's request for hearing or recommendation if no hearing requested	September 20, 2010
Deadline for Oncor's response to intervenor comments and Staff recommendation, Oncor's request for hearing, and proposed final order if no disputed issues	September 23, 2010
