Proc. R 22.102, 22.103 and 22.104. Intervenors would respectfully present the following:

I. Background

On August 24, 2010, an Order Establishing this Docket was issued by the Commissioners to determine whether the Gillespie-to-Newton (GTN) transmission line is necessary or whether there are more cost effective solutions than this specific line to accomplish the goals of the CTP in conformance with PURA § 39.904(g)(2) and P.U.C. SUBST. R. § 25.174(c). This Motion to Intervene is timely filed.

II. Interest

1. Margaret and Grady Rylander are trustees for a property that is directly crossed by the C7 segment of the alternate routes designated as GN1, GN2, and GN3 in the LCRA application subject of docket 37448.
2. Margaret and Grady Rylander were active intervenors in docket 37448.
3. Margaret and Grady Rylander have both testified before the Texas PUC concerning the proposed Gillespie to Newton CREZ transmission line (docket 37448).
4. Margaret and Grady Rylander have filed a letter to the Commissioners in this docket (item 7) outlining the need for ERCOT to re-study alternatives to GTN.

If I file testimony, I may be cross-examined in the hearing;


If I file any documents in the case, I will have to provide a copy of that document to every other party in the case; and

I acknowledge that I am bound by the Procedural Rules of the Public Utility Commission of Texas (PUC) and the State Office of Administrative Hearings (SOAH).


### V. Request
