RE: SOAH DOCKET NO. 473-11-0945, PUC DOCKET NO. 38743

- Staff-1-1 No, I do not have a habitable structure near any segment of the proposed transmission line.
- Staff-1-2 Yes, two segments of the proposed lines cross my property. Proposed segment B23 crosses my property along existing 138 KV line. Also, segment B22, immediately north of Haskell County Road 288, crosses my property where B22 crosses U.S. 277.
- Staff-1-3 Yes, an existing transmission line 138 KV crosses my property. It parallels the proposed B23 transmission line.
- Staff-1-4 Yes, an existing transmission line 138 KV crosses our property. It is approximately one mile from our place of residence and is visible. The current existing line is a double-pole line that is an inconvenience to plow around.
- Staff-1-5 No, there are no current windmills located on my property.
- Staff-1-6 I am not aware of any directly affected landowner that did not receive notice of the proposed transmission line project from ETT.
- Staff-1-7 No, I have not discussed any modifications to the proposed transmission line route on my property with a representative of ETT.
- Staff-1-8 My specific concerns about the proposed transmission line: I make my livelihood solely from farming. The transmission line would be a great inconvenience in my farming operation in that it would be difficult to maneuver large equipment required in farming around the poles and under the lines. I would lose acreage due to the proposed transmission line and it would greatly decrease the value of my property, both for farming and for hunting purposes.
- Staff-1-9 Yes, I attended an open house presented by ETT concerning this proposed transmission line on March 23, 2010 at the Munday High School gymnasium.
- Staff-1-10 The property boundaries were represented accurately, in my opinion.
- Staff-1-11 The primary use of my property is agriculture, both row-crop and ranching. The proposed transmission line would be a great inconvenience in both operations.
- Staff-1-12 There is no specific feature of my property that would affect the transmission line.

Staff-1-13 I am the sole owner of the property.

Staff-1-14 If the transmission line is routed on my property, I would prefer segment B22 at the crossing of U.S. highway 277 just south of the Knox-Haskell County line.

Staff RFA 1-1: I deny that I own or reside in a habitable structure within 500 feet of the centerline of any proposed transmission line route in the docket.
