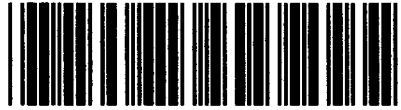

H. R. Clay Ranch Management, LLC requests that all pleadings, orders, correspondence, discovery and filings be served on its legal representative.


III.


