ADMINISTRATIVE LAW JUDGES:**

COMES NOW Oncor Electric Delivery Company LLC ("Oncor" or the "Company") and files this Agreed and Unopposed Motion to Modify the Procedural Schedule and Request for Expedited Relief ("Motion"), respectfully showing as follows:

I. MOTION

The parties are still engaged in settlement discussions. In order to facilitate those continued discussions, Oncor requests that the procedural schedule adopted in Order No. 9 (April 1, 2011) be modified such that the deadline for Intervenor direct testimony, currently due on April 5, 2011 at 5:00 pm, be extended to April 6, 2011 at 12:00 noon. Counsel for Oncor has communicated with all of the parties to this proceeding, and all parties have either indicated that they support or are unopposed to these modifications, or have yet to respond, although Oncor is not aware of and does not anticipate any opposition.

In light of today's deadline for intervenor direct testimony, Oncor respectfully requests that Your Honors issue an order granting this Motion today, so that parties may avoid filing testimony under the currently effective procedural schedule.

II. PRAYER

WHEREFORE, PREMISES CONSIDERED, Oncor respectfully requests that Your Honors grant this Motion as set forth above.
