On February 7, 2011, the following parties participated in a settlement conference in the above referenced dockets: Staff, CPS Energy, CenterPoint Energy Houston Electric, Oncor Electric Delivery, Texas Municipal Power Agency, the City of Garland, Denton Municipal Electric, Floresville Electric Light and Power System, San Miguel Electric Cooperative, Texas-New Mexico Power Company, Austin Energy, AEP Texas Central Company, AEP Texas North Company, Bryan Texas Utilities, GEUS, and South

Texas Electric Cooperative. During the negotiations, specific parties agreed to distribute additional information relating to their positions in these proceedings. All parties at the settlement conference agreed that additional time is needed to review the information. Accordingly, all parties agreed that the prehearing conference currently scheduled for February 8, 2011 should be rescheduled to February 28, 2011


WHEREFORE, PREMISES CONSIDERED Staff requests that the ALJ reschedule the prehearing conference until February 28, 2011.
