Telephone Cooperative, Inc. Pursuant to SUBST. R. §26.171

NOTICE ADDRESSING SUFFICIENCY AND PROCEDURAL SCHEDULE

On May 21, 2012, Cumby Telephone Cooperative, Inc. (Cumby Telephone or the Applicant) filed an application with the Public Utility Commission of Texas (Commission) for revisions to its Local Exchange Tariff to increase the rates to the 1-Party Local Exchange Access Line for all residential customers. The Applicant also proposed to add a new Flex Pak that will offer 2, 4, or 6 Mbps broadband service to its residential customers. In addition, Cumby Telephone proposed to add the following new service charges in Section 2: Central Office Access Charge, Expedited Due Date Charge, Premise Visit Charge, Reconnection Charge, and Termination Charge, and Miscellaneous Services in Section 5, Enhanced Customer Calling Services, Selective Call Rejection, and the Hunting Line Service for customers as specified in its Local Exchange Tariff. Cumby Telephone proposed an effective date of June 1, 2012.

On May 29, 2012, Commission Staff filed a recommendation on sufficiency of the application, as revised on May 25, 2012, notice and proposed procedural schedule. Commission Staff also stated that the Applicant's notice is sufficient and in compliance with the statute.



Consistent with Commission Staff's recommendation, Cumby Telephone's application, as revised, is deemed sufficient. The Timeline issued previously is affirmed and the dates remaining are as follows:
