Standing to Intervene

Texas-New Mexico Power Company is a Transmission Distribution Utility serving diverse areas of the State of Texas and is an electric utility and public utility as defined in PURA.

TEXREP1, LLC d/b/a EPCOT Electric, EPCOT, EPCOT Energy (TEXREP1) is a certificated Retail Electric Provider ("REP") serving each of TNMP's service areas, contracted with TNMP for delivery service under the rates, terms, and conditions of its tariff for Retail Delivery Service ("Tariff"). Furthermore, TEXREP1 has failed to pay over \$ 29,995.80 in charges to TNMP for service supplied under referenced Tariffs. TNMP therefore has a justicable interest, which may be adversely affected by the outcome of these proceedings and has standing to intervene.

WHEREFORE, premises considered, TNMP respectfully moves to be granted party status in this proceeding and for such other and further relief to which it may be justly entitled.
