WIND ENERGY TRANSMISSION TEXAS, LLC'S STATEMENT OF CONFIDENTIALITY CONCERNING WIND ENERGY TRANSMISSION TEXAS, LLC'S RESPONSE TO STEERING COMMITTEE OF CITIES SERVED BY ONCOR'S TENTH REQUEST FOR INFORMATION

TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:

Wind Energy Transmission Texas, LLC ("WETT") files this Statement of Confidentiality Concerning Responses to the Steering Committee of Cities Served by Oncor's ("Cities") Tenth Request for Information.

#### I. Background

WETT is providing responses to Cities' Tenth Request for Information. The attachments to the responses to the requests listed below contain sensitive commercial information that is considered confidential and/or highly sensitive confidential, and as a result, the attachments were provided under the Highly Sensitive Protected Material designation (material so designated is hereinafter called "Protected Material") pursuant to the Protective Order entered in this Docket. This statement is being filed to comply with the requirement of Paragraph 4 of the Protective Order related to claims of exemption from public disclosure pursuant to the Public Information Act. WETT asserts that the information that has been marked as Protected Material is exempt from public disclosure pursuant to sections 552.101 and 552.110 of the Texas Public Information Act ("TPIA").

### II. Argument

The Protected Material is exempt from disclosure under the TPIA because it contains confidential competitively-sensitive information, the public disclosure of which would cause substantial competitive harm to WETT or other parties.

The Protected Material is considered confidential under P.U.C. Substantive Rule 25.272(c)(3). The Protective Order in this Docket specifically recognizes this type of sensitive

business operations and financial information as Protected Material that can be used only for the specified purposes in this Docket.

Counsel for WETT has reviewed the Protected Material sufficiently to state in good faith that the information contained therein is exempt from public disclosure under the TPIA and merits the Protected Material designation. WETT has provided information designated as Protected Material in response to the following requests:

### Cities' RFI No.10, Questions LK 10-1 and 10-2:

Question LK 10-1 references a confidential workpaper and was filed as confidential. Question LK 10-2 references a highly sensitive confidential workpaper and was also filed as confidential. The attachment to Question LK 10-2(c) provides detailed information regarding a third party's business practices and rates, and was characterized as highly confidential and proprietary when provided to WETT by the third party. Such data constitutes sensitive business operations and/or trade secrets, the public disclosure of which would prove detrimental to the third party.
